Dear Mr. Ruben,

The reason I went to law school was to serve veterans, specifically regarding disability compensation and discharge upgrades. Through the Equal Justice America Fellowship, I was able to live out my passion over the summer at Legal Aid of North Carolina's (LANC) Veteran Law Practice Group.

I primarily assisted in cases concerning low income or poor veterans with an other than honorable discharge in need of discharge upgrade. An other than honorable discharge has so many negative effects on a veteran's life. The discharge bars them from HUD-VASH housing and other public benefits including VA healthcare. The greatest indignity though for these veterans though is the VA's determination that they are not veterans for the VA's purposes. I became very aware of how important the discharge upgrade process was to veterans. It can literally change their life.

One example of this life changing upgrade is a veteran who was given an other than honorable discharge for smoking marijuana. He presented symptoms of PTSD while in service. He did not receive proper treatment for his PTSD and resorted to self-medication through marijuana. The military did not do its job to help this service member and gave him an other than honorable discharge. The discharge prevented him from gaining housing assistance and became homeless as a result. Through the LANC Veteran Law Practice Group's efforts, we made the argument to a discharge review board that the veteran should not carry the burden of an other than honorable discharge because of his PTSD. While I left before the decision was received from the discharge review board the veteran was so thankful that someone would just listen to his story. That someone cared about him.

While at LANC I was also able to represent clients in other legal matters. LANC emphasized that all interns should have the opportunity to litigate a case at some point during the internship. Veteran law cases take a very long time with few opportunities to litigate a case at a hearing. Knowing this was the case, my primary supervisor assigned

me to help with an unemployment case another attorney was working on. I worked hard with the client and building their case in preparation for the hearing. Unfortunately, the result did not go in the client's favor. However, the client was nonetheless so appreciative of the work I and my supervising attorney did for them. Despite the result, I am thankful I got to have the experience of representing someone and being a zealous advocate on their behalf.

I would have gladly taken this internship without a stipend. However, I would have had to split my time between the internship and another job to help with my expenses over the summer. Thanks to the Equal Justice America Fellowship I was able to dedicate all of my time to the efforts of Legal Aid of North Carolina. My experience over the summer confirmed not only that I want to practice veteran law but also practice veteran law in a public service environment. I am truly grateful that Equal Justice America made this opportunity possible.
