That is why I decided to clerk for the Economic Stability Work Group at LAFLA and I have NO REGRETS. While clerking for LAFLA, I contributed to an opening brief for a client whose government benefits were terminated. The writing process was challenging but I grew to enjoy legal writing. Throughout my legal writing process, I conducted legal research and found it is something I'm skilled at. Aside from working on the opening brief, I participated in several client intake calls for clients dealing with government benefit issues during which I learned why active listening and asking questions is crucial for counsel and advice. I was able to personally assist a client with her SSI reduction, which also involved plenty of legal research. It is fulfilling to know I helped someone who would have otherwise not known how to proceed with her appeal.

I've mentioned this before but I learned quite a lot about myself this summer, aside from all that I learned as a law clerk. I learned that although I love creative writing, I enjoy and appreciate the structure of legal writing. I learned that I enjoy legal research so much because it provides me the opportunity to learn different things through the potentially endless search results at times. However, I learned that it's ok to sometimes deviate from the structure of legal writing, but only if it's done right of course. (Haha). I also learned that legal research sometimes doesn't lead us to a clear answer, because it just might be that there isn't a clear answer, and that's ok too. Most importantly, I learned that self-care is super important because we must feel good to do good and we most definitely cannot pour from an empty cup.

I started at LAFLA feeling some self-doubt (imposter syndrome puts up a good fight), but I left feeling confident, powerful, capable, and valuable.
