LAF is the largest provider of free civil legal representation in Cook County, Illinois. During his time at LAF, Carly worked in the Housing Practice Group advocating and representing tenants living in low-income subsidized housing.

Carly researched engineering issues concerning mobile homes, legal issues pertaining to flood plains and found local and federal statutory provisions that were relevant to the case. This was a completely new area for many of the attorneys at LAF and required a lot of work to be completed in a very short period of time. When we asked for help, Carly didn't even flinch before volunteering. Not only did she complete the work, she did it quickly and she did it well be creating well written memos, organizing data, and developing plans.

Carly also worked with clients in every stage of the eviction process including conducting intake interviews, assisting with a legal clinic, carefully drafting pleadings and motions, and settling



cases. Carly was always thoughtful and invested in her work showing a genuine interest and concern for our clients.

In a nutshell, Carly is intelligent, diligent and hard-working. She seemed to excel in the completion of every task that she was asked to complete. We all enjoyed working with her as well. Carly provided the burst of optimism and commitment that we all needed over the course of a difficult summer.
