Dear Mr. Ruben,

I came to Georgetown Law in order to pursue a legal career of representing individuals who had experienced gender violence. Thus, for my first summer internship, I jumped at the chance to represent mostly domestic violence and sexual violence survivors as an intern in the Family Law Unit at Philadelphia Legal Assistance in Philadelphia, PA. I greatly depended on the assistance from Equal Justice America this summer, and I appreciate that I was able to focus on my passion of directly serving survivors because of the support from EJA.

While at Philadelphia Legal Assistance (PLA), I assisted about fifty clients. I assisted these clients with their custody, protection from abuse, child support, and spousal support cases. All of my clients were below the poverty line, with many clients in extreme poverty. Many of my clients depended on government services, such as food stamps or social security disability benefits, some of my clients were homeless, and some of my clients only had a few dollars to live on for the week. Most of my clients also experienced domestic violence from the opposing party in their case, and sexual violence from either the opposing party or someone else in their life. For example, I worked with one client who had to flee her home and state in order to leave an abuser. Thus, she needed extensive assistance from me in her custody battle since she was no longer in the area and thus did not have access to her child. I also assisted another client who had been raped by the father of her child in her custody case. However, once she got to court, she was too nervous and ashamed to tell the judge that the father had raped her, and thus the father was awarded shared physical custody. I worked with her to bolster her confidence in court to bring up her rape, streamline her arguments so she could be more focused, and to gain her trust so she would know that she was not alone in her emotional and trying custody case.

PLA has a very organized legal internship program that provided us with a system of assisting clients. First, I would perform an initial intake of a client either in person or over the phone. During this intake, I would ask a number of questions to figure out the client's goals, what were the biggest obstacles that the client faced in achieving those goals, and other general issues that the client faced (whether related to family law or not). Once we established their goals and obstacles, I would provide information about custody, abuse, and support law in Pennsylvania. If they had an upcoming court date, I would assist in preparing their arguments for court. If they did not have a court date, we would work together to decide if they should file a petition or complaint for a court date. I drafted numerous documents for many of my clients, including complaints for custody, petitions to modify custody, motions for expedited relief, motions for a home investigation or mental health evaluation, and many letters to judges on behalf of clients. I had to stay meticulously organized so that I could efficiently follow up with clients over the phone or email. If the case was particularly complicated or sympathetic, I would present the case

to the attorneys for possible representation, or I would refer the case to an outside organization that could provide representation.

I sincerely enjoyed my internship at PLA. I came to law school to help survivors, and I was able to fulfill that dream this summer. I always thought that I would want to work in direct legal services, and through this internship I was able to learn that I indeed love direct legal services and that it is a good fit for me. I am confident now that I want to pursue a public interest career in direct legal services, and the support from Equal Justice America gave me the opportunity to find that confidence.
