Dear Mr. Ruben

Thank you for the opportunity to spend my summer doing what I was born to do, help children. This summer I had the pleasure of interning at Alliance for Children's Rights (The Alliance), a nonprofit organization, which provides free legal services and advocacy to impoverished, abused and neglected children and youth in Los Angeles County. I specifically chose to be in Los Angeles this summer as it the country with the largest population of foster youth in the United States. The Alliance is an organization that takes a holistic approach to helping children. Not only do they offer free legal services to their clients but they also provide training and education for those who work with or care for these neglected and impoverished children. The Alliance has a specific goal to cause system-wide reform

During my time at the Alliance I worked within the Guardianship Program. The Alliance helps eligible caregivers become legal guardians of the children in their care by representing them in probate court. These matters involve children whose parents cannot care for them. These children have not yet entered the foster care system and are living with a relative or non-relative caregiver. One common issue I ran into was a clients struggle to understand the law and the legal process. Many of these prospective guardians would have notarized letters from a parent that they believe give them legal guardianship. Unfortunately, I was often faced with the difficult task of gently explaining that Legal guardianship can only be established by a court, not by a notarized letter from a parent. Many of these cases were complicated, delicate but very fulfilling to work. One case in particular stands out to me.

I had the pleasure of helping a young woman, who sought legal guardianship of her two younger sisters, start the guardianship process. This young woman was an amazing, caring and driven person. Upon meeting her I was inspired and taken back at how selfless she is. This woman was married with two kids of her own and concurrently caring for her two elementary school aged sisters with disabilities and their terminally ill mother. As proposed guardian explained her situation in the initial client meeting, I could sense her frustration and doubt in the legal system, but there she was in front of me fighting for her sisters and trying to

provide. It was almost as if she expected us to give her useless information or a pamphlet to read and send her on her way. When my supervisor asked proposed guardian to sign the retainer agreement and explained that the Alliance would represent her at no cost her attitude completely changed from skeptical to relieved. No, her problems were not fixed then and there but it was so powerful to see the effect in extending that legal assistance.

This particular proposed guardian's case grew very complicated as the girls' father had been murdered 10 years ago and with a mother that was not able to make decisions and a deceased father neither parent could offer their consent to the guardianship.

Parental consent is something that a proposed guardian legally needs to acquire before she would be permitted to move forward. Currently this proposed guardian's case has been placed with a probono that will assist her in first getting a conservatorship of her terminally ill mother which will help her in providing consent on her mother's behalf. This proposed guardian wanted nothing but to care and provide for her younger sisters and although we did not get very far in the guardianship process it was awesome to experience this clients gratitude and feel like I was able to help relieve her of a great burden by offering legal help.

At this internship, I took on an immense amount of work. The cases were complicated and the details of many of the heart wrenching stories were difficult to handle at times. I found myself struggling between being desensitized by hearing the details of my clients circumstances and getting caught up in my feelings of sympathy. This is not an easy field to work in but it's necessary. I learned that it is alright to feel sympathy because for me that drives passion to help. I hope that as I continue to work in this field I will never grow desensitized and that no story of an abused or neglected child, or the details of a client's difficult circumstances will fail to stir up some kind of emotion. This field needs passionate people and clients can sense when they are seen as just another case verses when they are treated like a person who being helped through their individual legal issue. I want to be the type of lawyer that helps people not one that "handles cases." I've always known this but there was something special about speaking with the proposed guardian mentioned above that really drove that point home for me. Thank you again for the opportunity to help people and the opportunity to have my passion for this client demographic grow.
