## Mr. Ruben:

Thank you once again for the Fellowship award I was granted for my work at The Legal Project this past summer. I had an incredible experience working with The Legal Project and learned more about civil litigation that I ever anticipated.

My experience working with The Legal Project this semester has not only been an enjoyable and educational one, but one that has become a turning point for me in my legal education. Entering law school, I, like so many others, was uncertain of what direction my career would ultimately follow. However, after only a brief few months with The Legal Project, I can confidently say that I have found my direction. The important and often undervalued public interest work that The Legal Project does for victims of domestic violence is something that I strive to emulate in my own career, to continue to bring life-changing relief and respite to those who need it the most.
