Dear Mr. Ruben:

I was an intern at the Chicago Legal Clinic, Inc. during the summer of 2017. While the Clinic provides legal assistance in all areas of the law, my office focused on family based immigration. Throughout my internship I was able to observe many client meetings and developed a new appreciation for the impact an immigration attorney has on keeping families together.

I worked closely with a client applying for naturalization. While the client was completing the interview with the immigration officer, I waited with the spouse who shared with me the family's hopes for the future. Unfortunately, the client was not granted citizenship after the interview and we needed to provide additional evidence to the immigration officer. Over the following weeks, I worked closely with the client to provide the necessary documents for the request for additional information and drafted a letter to the immigration officer advocating why the client should be granted citizenship.

We received a response from the immigration officer a few weeks later and still more information needed to be provided before the application would be approved. I communicated almost every day with the client to obtain the additional information. Once all the documents were in order, the client and their spouse and children came to the office [to] review the letter I had drafted to the immigration officer. I could sense their relief and apprehension that this would

hopefully be the final hurdle before the client was granted citizenship. As of the last day of my internship the client was still waiting for a response.

It was a privilege to work with the clients such as this one and to be a small part of keeping these families together.
