Dear Mr. Ruben:

My name is Norah Sloss. I am a third year law student at the Catholic University of America Columbus School of Law. As a recipient of an Equal Justice America Summer Fellowship, I was able to work as a law student intern at the Legal Aid Society of the District of Columbia this summer. I worked within the Domestic Violence and Family Law Unit while at Legal Aid. The Domestic Violence and Family Law Unit represents low-income clients in civil protection order, child support, child custody and divorce cases. In addition to providing excellent direct client representation, the Domestic Violence and Family Law Unit focuses on systemic efforts to make justice real for families living in poverty in D.C.

As an intern in the Domestic Violence and Family Law Unit, I worked primarily on civil protection order cases. I worked closely with my supervisor to assist her throughout intake, case preparation and civil protection order hearings. The clients I worked with this summer were low-income women seeking protection from abusive relationships. Many of these clients were mothers seeking protection for themselves and their children. I helped these clients through collecting evidence, answering their questions about the civil protection order process, preparing them for their hearings and supporting them during the day of their hearings.

It was especially meaningful for me to work with women and children on such a personal level. I felt incredible knowing that some of the work I had done helped them to find safety from abuse and peace of mind. It was especially rewarding because I saw that without the help of a Legal Aid attorney, all of these women would have been forced to represent themselves, which would have been a challenge for many of them. While working with the Domestic Violence and Family Law Unit, I was able to focus more on my specific areas of interest and learn from excellent attorneys. By spending time at Legal Aid, I saw the power of legal services in action, which helped my commitment to public interest law grow stronger. I am very grateful to Equal Justice America for supporting my work this summer.

My name is Oluwemimo Peters, I am a staff attorney in the Domestic Violence and Family Law Unit at the Legal Aid Society of the District of Columbia. The attorneys in the Domestic Violence and Family Law Unit represent low income clients in child support, child custody, divorce and domestic violence cases.
