Dear Dan Rueben,

This summer I had the fortune of working at Legal Services of New York City at the Queens Legal Services office. Within Queens Legal Services, I worked as an intern in the Disability Advocacy Project and Education Law Unit. The beginning of my summer work primarily focused on education law cases due to the fact that school was still in session. The second half of my summer primarily focused on disability cases.

My work in education law primarily focused on school suspension cases. I did not know that school suspension or expulsion was a legal matter. I assisted in representing two students in school suspension appeal hearings at the department of education. These students were being suspended from school and their families could not afford legal representation. I got to do case research, client intake and prep, write questions for the hearing, and I attended the hearing to assist the attorney I worked with. The first hearing was very easy due to the presence of substantial evidence that our client did not commit the act the principal said they committed and the principal had blatantly fabricated the situation. That hearing proved victorious as the outcome was in our clients favor. The second case was a little bit more difficult. Despite a valiant and hard worked effort, we were not victorious in that case. Although we did not win that case, the attorney I worked with promptly filed an appeal for a new hearing. Winning the first school suspension case gave me a thirst for aggressive advocacy lawyering and losing the second case taught me to persevere and never give up for clients in need. Statistics show that school suspension and

expulsions are frequently used as a tool against low-income students to support the school to prison pipeline. I feel like this summer I was able to make a dent in that oppressive system.

The disability cases I worked on were primarily appeals of decisions to deny social security disabilities benefits from people who had applied for them. The reason why a lot of people lose disability claims is because they do not file the necessary documents needed to indicate to the social security administration that they have disabilities. For many of our clients I worked on requesting the proper medical, educational, or psychological documents needed to file to receive disability benefits.

For some of the clients I got to do more hands on work. For one of our clients, I worked on a brief that the attorney I worked under was submitting in a Federal appeal against the social security administration's decision not to award disability benefits. This helped me gain valuable writing experience.

The pinnacle of my summers work, however, was being asked to present at an administrative hearing on behalf of one of our clients. Our client was appealing a decision not to receive disability benefits from the social security administration. I worked on the case from start to finish and we have not received the official decision yet.

Overall, I had a wonderful experience doing public interest this summer. I learned valuable lawyering skills and I strengthened myself as an advocate. I would not have been able to do this work if it was not for Equal Justice America assistance. Because of Equal Justice Americe I was able to effect peoples lives for the better.


