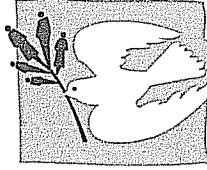
My summer fellowship experience was incredibly enriching and fulfilling. I split my summer between two organizations: seven weeks at Texas Rio Grande Legal Aid and seven weeks at Family Violence Prevention Services. At TRLA, I worked in education, family law, and housing. At FVPS, I worked in family law cases that involved domestic violence.

It was very interesting to get such a variety of work in my summer, and at the same time get to really focus in on some of the areas of law that I am most passionate about. Also, because I had a temporary trial card, I was able to provide more direct legal assistance than in previous internships. I interviewed clients, prepared cases, represented clients in court and at administrative hearings, drafted pleadings, and did research. In both internships, I was able to help people who had nowhere else to turn. From dealing with an eviction, to having major problems in school, to being the victim of domestic violence, our clients were dealing with issues for which they needed crucial legal services that they could not otherwise afford. Through my work in these internships, I was able to help women leave their abusers while maintaining their safety and being able to protect and support their children. I was able to help people stay in their homes. I was able to help children get the services and support they deserve in school.

Overall, I have loved working with organizations that play such an important roll in helping others and addressing serious legal needs in this country. My experiences this summer were so meaningful that I am now applying for fellowships to work at FVPS after I graduate from law school. I am very thankful that the Equal Justice America grant made it possible for me to have such great internships!


