Entry 1: Week of 6/11/2018

#EJAFellowUpdate

I'm spending my summer working at Massachusetts Advocates for Children, an organization that seeks to combat the significant barriers to equal educational and life opportunities for children. Over the past few weeks, I have worked with attorneys at MAC to support transition age students with disabilities (ages 18-22) on an individual basis and through MAC's policy work. I'm particularly excited to be working on MAC's initiative to expand access to higher education for these students in transition through the MAICEI grant program and legislation to remove barriers to access.

Entry 2: Week of 6/25/2018

Since my last update, I have been able to participate in the coalition work that MAC convenes and I have learned how important it is to collaborate with others in the child welfare and education space. I attended a B-SET meeting, a network Boston Public Schools, state and other city agencies; employers, unions and job developers; and youth service, disability and parent organizations, which MAC convened. This particular meeting focused on the Intersection of Disability, Race, and the School to Prison Pipeline to learn about how our work can remove barriers for students. Entry 3: Week of 7/9/2018

In the past few weeks, I have continued to assist transition aged students (ages 14-21) with disabilities and their families through MAC's Special Education Transition Project. I've been able to attend an IEP team meeting and draft responses to proposed Individualized Education Programs (IEP). I've had the unique experience of discussing special education advocacy and representation with MAC's Young Adult Leaders Fellow, which I've used to inform my work with transition aged students. The fellowship offers an opportunity for young adults 18-26 with intellectual disabilities and/or autism to learn the professional skills needed to advocate on behalf of other youth with disabilities.

Entry 4: Week of 7/23/2018

Last #EJAFellowUpdate

I have about one week left at MAC, so I'm pushing to wrap up some of the longer term research I've done on school discipline for children as young as 3 years old and on access to higher education for individuals with intellectual disabilities. I have had an amazing experience here at MAC this summer and have learned so much; I'm so grateful for the support and mentorship from the entire staff. In the fall, I will continue to work with low income children as part of the BC Law Juvenile Rights Advocacy Clinic.
