Dear Mr. Ruben:

This summer I had the privilege of working in the Supplemental Security Income (SSI) Unit at Community Legal Services (CLS) of Philadelphia. This experience strengthened my commitment to civil legal aid and direct service. I am very grateful for Equal Justice America's support in pursuing this opportunity.

CLS provides a full range of free civil legal assistance to low-income Philadelphians. These services range from individual representation to class action litigation and community education. The SSI Unit represents clients facing termination or denial of SSI benefits. I learned from committed advocates who encouraged me to learn by doing, by discussing, and by critically examining the legal process.

In my capacity as an intern, I had the opportunity to work on a variety of cases and assignments. I primarily focused on appeals of adverse SSI disability determinations, though I also advocated cases involving allegations of overpayment by the Social Security Administration (SSA). I analyzed medical evidence to develop a theory of the case, wrote briefs, interviewed clients, and researched case law and administrative rules. Most importantly, I had the opportunity to directly support our clients through explanation of the administrative process, preparation for testimony, and direct representation.

One case in particular stands out to me. The client had long-standing impairments due to severe depression and anxiety, yet the SSA found he was no longer disabled, and therefore ineligible for SSI benefits. I worked on this appeal from beginning to end, collecting evidence, preparing a brief, and representing the client at the reconsideration hearing. I remember his frustration and confusion as he explained the impossibility returning to work or meeting basic needs without receiving SSI benefits. I will never forget the look of relief on his face when he learned that his benefits would be reinstated.

My experience at CLS helped me to better understand the barriers our clients face in seeking modest benefits. Our clients suffer daily from severe medical impairments while also confronting bureaucratic limitations (claimants in Philadelphia wait more than 2 years for a hearing!) and dangerous misconceptions of disability. Even when medical records provide strong evidence of disability, these individuals lack the capacity and resources needed to navigate the legal system alone. I am more committed than ever to providing direct services to vulnerable individuals.

Thank you again for your support in pursuing this opportunity.
