I choose to go to law school and build a career in housing policy because I know that when our neighbors don't have access to adequate housing, our whole community suffers. The Legal Aid Society of Milwaukee does incredibly important work in helping stop evictions, prevent homelessness and foreclosure, and combat the housing discrimination that makes Milwaukee our nation's most segregated city.

This summer, I've been able to gain valuable experience as an Equal Justice America Fellow at Legal Aid – experience that will make me a better advocate for those in need in the years to come.

The bulk of Allison's assignments were related to my largest litigation matter, where Legal Aid has sued one of the largest land contract/rent-to-own vendors in the country on behalf of three individual clients. The State of Wisconsin was the original plaintiff in the case and we successfully intervened, along with 6 other individual plaintiffs represented by other legal services organizations. Allison completed research assignments involving intervention, stolen documents, taint, and the scope of an intervenor's discovery. She also helped out with some organizational tasks that we undertook to manage the large volume of filings in the case. Allison's written memos analyzing the results of her research were clearly written and cited to appropriate legal authority. She also asked good questions along the way when she was unsure about something. Her work on this case was truly helpful to me as I drafted briefs and prepared for hearings this summer.

Allison also completed projects involving the investigation, analysis and organization of key factual evidence. She analyzed a complicated history of mortgage servicing transactions and prepared an easy-to-understand summary of events for use in a mortgage servicing matter. She also organized six months of bank account transactions for use in a bankruptcy case.
