Thanks to the generosity of Equal Justice America, I had the great fortune of working at Disability Rights New Jersey this past summer. Disability Rights New Jersey is a non-profit organization established to advocate for and advance the human, civil, and legal rights of citizens of New Jersey with disabilities. By working with the dedicated and passionate staff members at Disability Rights New Jersey, I developed a deeper understanding of the legal challenges that many persons with disabilities regrettably face and I was able to learn the ways in which disability attorneys advocate for their legal rights.

During my time at Disability Rights New Jersey, I worked closely with several attorneys on a variety of assignments ranging from preparing research, to drafting pleadings, to even conducting investigations. I conducted research and prepared memoranda on a variety of topics related to disability rights, including issues related to the Division of Vocational Rehabilitation Services, the Department of Children and Families' Children's System of Care, and other issues with systematic implications. I was also provided the opportunity to draft pleadings on an Americans with Disabilities Act discrimination case that were submitted to the United States District Court for the District of New Jersey. I found this assignment to be particularly rewarding, as it allowed me to advocate for the rights of a prisoner with paraplegia who has been denied access to basic medical supplies during his incarceration.

Many clients at Disability Rights New Jersey contact the organization to request legal assistance when their Medicaid services have been denied or reduced. During an ongoing Medicaid Fair Hearing, I was responsible for conducting the investigation of a client's claim for additional Medicaid services. I interviewed the client's physicians, therapists, and family members in order to gather evidence to support her request for additional Medicaid services.

In addition, I was also provided the opportunity to accompany advocates at Disability Rights New Jersey to state psychiatric hospitals and developmental centers to assist in monitoring the conditions at these institutions. I will never forget the observations I made while monitoring these institutions.

I am so appreciative of Equal Justice America for providing me with the ability to spend this past summer working at Disability Rights New Jersey. This internship allowed me to improve my advocacy skills while serving a vulnerable population. The attorneys and advocates at Disability Rights New Jersey truly do amazing work and I feel so lucky to have been a part of it.
