Our hope is to equip social workers and attorneys to support Philadelphia's prosecutors to push for the contemporaneous testimony of child victims and reduce the traumatizing impact on children of testifying about the crimes committed against them.

Dear Equal Justice America:

This summer Karissa Phelps interned with us at the Support Center for Child Advocates. She worked closely with our social workers, staff attorneys, and volunteer attorneys throughout the summer in our work with children involved in the child welfare system in Philadelphia, PA.

Karissa shared a caseload with myself and one of our supervisors and contributed in a variety of ways to our work. Karissa coordinated with DHS workers, social workers, attorneys, school personnel, doctors and parents to advocate for the interests of foster children in a variety of settings. She contributed to the successful reunification of a client this summer with his biological mother after years of being in foster care and advocated for another child to move from a general foster home to the kinship home of her grandmother. She assisted in obtaining vital documents for a teen client to get a job, in getting the client into an alternative school setting for his academic success, and connecting him to key resources for older foster youth.

Karissa advocated for appropriate services for a family of five siblings facing issues of truancy and domestic violence. She supported volunteer and staff attorneys in permanency hearings and helped prepare witness testimony for a contested Termination of Parental Rights hearing. At the end of the summer, she researched and trained social workers on testimony by contemporaneous alternative method and how to advocate for its use in criminal trials where our client is a child victim or witness.
