Through this matter, I've had opportunities to substantively interact with our client and co-counsel. That practical experience has been invaluable. Further, the opportunity to engage in such important work has solidified for me that I am committed to a career in working on issues of police abuse and advancing justice for those who have been failed by our criminal legal system. Police misconduct and violence is far too common in the United States, especially in cities like Washington, DC. With the use of Special Police Officers (contracted law enforcement that receive little training) now increasing in the District, the safety of our communities is increasingly at risk. I am motivated to continue fighting for justice and for reforming and abolishing the systems that cause such injustice. I am thankful to Equal Justice America for funding my summer internship.

Update 5:

A couple of weeks ago, I wrapped up my summer internship at the Washington Lawyers' Committee for Civil Rights and Urban Affairs. The summer absolutely flew by! During the last few weeks of my internship, I had the opportunity to get involved with a handful of experiential opportunities, primarily conducting intakes with individuals who reported experiencing police abuse. I found that experience to be incredibly valuable. Not only did I learn skills that are central to working with prospective or current clients, but I also got to interact with members of a community that I aim to serve in my career. Through those interactions, I gained insight into the specific policing issues that those who are most impacted by police misconduct are concerned about.
