**Update 1:** I'm happy to share that on May 31st, I started my summer internship at MetroWest Legal Services. I'm splitting my time between their Civil Legal Aid for Victims of Crime and Medical-Legal Partnership units, and I have already seen the unique benefits of the interdisciplinary approach these programs apply to legal services. I'm excited to return to client-facing work this summer, and to explore multiple areas of practice including immigration, family, and domestic violence law.

I'm also fortunate to have received an Equal Justice America fellowship to help fund my summer of public service. This grant, along with my public interest summer funding from Boston University School of Law, made it possible for me to spend my summer doing work I am passionate about. I'll be sharing EJA Fellow updates throughout the summer reflecting on my work at MWLS.

**Update 2:** For my second EJA Fellow Update, I wanted to share more about the Civil Legal Aid for Victims of Crime ("CLAVC") project I am working on this summer. I will be walking away from this summer with a new understanding of holistic representation, and huge admiration for the dedicated, zealous advocates at MWLS!

**Update 5:** I've wrapped up my summer with MetroWest Legal Services and am reflecting on my experience for my final EJA Fellow Update.

I learned so much this summer from my supervisors, colleagues, and fellow interns. It is rejuvenating to work with a team of people who are similarly committed to serving the public interest, and who have dedicated their careers to working with low-income clients. Not only did my colleagues at MetroWest provide excellent services to their clients, they took extra care to learn about the issues facing their community, partner with other social service agencies, and remain engaged in policy-level advocacy—bringing their expertise from firsthand interactions with clients to macro-level social justice movements.

I was also lucky enough to spend a great deal of my summer working directly with clients. Among other projects, I was able to assist in stabilizing a client's financial situation after identity theft, filing a number of petitions for immigration relief for noncitizens who had been victims of crimes, and helping a survivor of domestic violence file for divorce. I am going into my third and final year of law school feeling re-inspired and excited about the work I will get to do once I am a full-fledged attorney.

MetroWest Legal Services is a small but mighty legal aid office in Framingham, MA, serving low-income people, people with disabilities, and people over the age of 60 in their service area.
