During my time at the foundation, I've had the privilege of working on a diverse range of legal matters that have deepened my understanding of the law and reinforced my commitment to serving our clients' needs. Here are some highlights from my journey:

• Immigration Law: I have focused on applications such as VAWA, T Visa, and U Visa. It has been immensely rewarding to assist victims of trafficking and some other crimes seeking protection.

- Family Law and Domestic Violence: I have worked on cases involving the application of Domestic Violence Restraining Orders and dissolution proceedings, ensuring the safety and well-being of those in vulnerable situations.
- Government Benefits Advocacy: I've focused on appealing decisions made by agencies regarding essential benefits such as Medi-Cal, CalFresh, CalWORKs, and EDD. Securing these benefits is crucial for our clients' survival, often making a life-changing impact.
- Tenant Rights Advocacy: Defending tenants' rights and preventing unjust evictions has been another vital aspect of my work. I strive to ensure that our clients are not unfairly evicted without just cause or due process, offering them stability and a voice in the face of challenging circumstances.
- Employee Rights: Protecting the rights of employees has been a fulfilling part of my legal practice. I have fought for fair compensation, ensuring that individuals receive their entitled overtime payments and enjoy legally mandated breaks.

## **Update 3: ○** Improving Language Access at EDD: Advocating for Public Interest

In my work on appealing the Employment Development Department (EDD)'s decisions, which often reduce or deny benefits and impose penalties on limited English-speaking clients, I've come to recognize the crucial need for language services provided by California's governmental entities.

EDD handles job development and unemployment benefits, including UIB and PUA. However, API face difficulties accessing EDD services due to overwhelmed phone lines without language support.

Legal Aid Foundation of Los Angeles (LAFLA) has proudly played a crucial role in improving language access at EDD, by filing the initial complaint that triggered this mediation. Through a recent settlement, EDD will provide real-time translation services, expand phone lines to include the top seven non-English languages, and translate vital unemployment insurance documents into 15 languages by 2024.

These developments reinforce my understanding of the transformative power of laws and legal aid in advocating for public interest. Let's continue to champion language access rights and work towards a more inclusive future.
