One of my biggest takeaways is the importance of listening. Effective lawyering isn't just about knowing the law; it's about truly understanding the needs and stories of those you serve.

This summer, I witnessed every decision being made with the client in mind. Litigation lawyers must be strategic when communicating the law, but ultimately, those choices must reflect the client's lived experience. Listening to your clients with empathy and attention to detail can make a significant difference in the strategies you choose and the impact you make.

I've had the privilege of working alongside passionate and dedicated professionals who exemplify these principles daily. I'm grateful for this experience and look forward to applying these lessons in my future endeavors as an advocate for justice.

**Update 5:** My amazing summer with Public Counsel has come to an end, and I am excited to reflect on my experience in my final EJA Fellow update! Working with Public Counsel and participating in Equal Justice American's fellowship program has not only strengthened my

passion for public interest law and plaintiff-side litigation but also allowed me to contribute meaningfully to cases focusing on advancing civil rights and social justice.

This summer, I had the opportunity to work on two significant cases with the Opportunity Under Law team: one advocating for disabled veterans seeking access to housing and health care, and another focused on securing safe, stable housing and supportive services for transition-age foster youth. Both cases highlight the importance of legal advocacy in holding institutions accountable for failing to meet their obligations to vulnerable communities. These cases demonstrate how important legal intervention can be in protecting the rights of those so often overlooked.

Throughout this experience, I've come to appreciate how collaborative public interest litigation is. The OUL Team worked closely with various Public Counsel projects, pro bono partners, paralegals, and social workers. Seeing how diverse perspectives and training came together to advance justice for our clients was always interesting. Additionally, I learned the importance of remaining calm and flexible when on these cases. When working on complex class action cases, there are many moving parts operating all at once. Whether it's changes to client circumstances, changes to the law, changes to staffing, or anything in between, lawyers must have a vision for adaptability. While working with pro-bono clients, I often saw this implemented as taking the extra step to meet clients where they are, both in terms of physical location and emotional empathy.
