No matter how much you want to help a client, you cannot care for them more than they care for themselves. I am grateful to EJA and the financial support provided to me.

Update 4: One of the best advices that I've gotten upon entering law school was to keep an open mind and not close my doors to learning opportunities outside the scope of what passions me. This is why I didn't hesitate to jump on the opportunity to serve as student attorney with the Harvard legal aid bureau this summer.
