It's time for another <u>#EJAFellowUpdate!</u> As I've settled into my role as a legal intern at the Housing Initiative Transactional Clinic at The University of Chicago Law School, I've found myself engaging in meaningful work supporting non-profit housing developers and cooperatives.

While much of law school is focused on the litigation side of the work available to a lawyer, this summer has given me experience with different forms of transactional work.

More importantly, it has given me the opportunity to support disadvantaged communities in my area. By offering pro bono services to support these projects, we are able to help ensure that families with lower incomes have access to affordable housing. One thing we have been able to do for our clients is to help them navigate the bureaucracies in order to see their projects come to fruition so as to achieve the goal of affordable housing even as gentrification overtakes many of the neighborhoods of Chicago

With City of Grants Pass v. Johnson having been handed down, it may be more apparent than ever just how important access to affordable housing is for our disadvantaged communities. That is why we need to leverage our talents to support them and why the work done by Equal Justice America is so important.

It was a rewarding experience that involved both insight into the organization's business and also the skills of class-based programming that I gained so many years ago.

I was also able to work directly with a different client providing legal advice on his low-income housing project. This was great not only because of the leveraging of my interpersonal and customer service skills from past jobs, but also my problem-solving and research skills of both my undergraduate and legal education. Further, it was a very rewarding experience to be able to communicate with a client directly and answer his questions to help him resolve the difficulties that arose in his project. By resolving those issues, it helped him along the process of providing accessible housing to more people.

It's time for the last #EJAFellowUpdate! It's the end of the summer, and with that, the end of my time as an Equal Justice America fellow. However, it won't be the end of my time with the Housing Initiative Transactional Clinic, where I intend to continue working into the academic year.

With this being the last one, let's make it a recap. Initially, I expected just to gain experience in transactional law, which contrasts with the litigation focus of our curriculum, in the hopes of teasing out where my own career interests lie. However, this internship has shown me the profound impact of my work and its importance for the community. A significant highlight of my summer is being named a 2024 Equal Justice America Fellow. This fellowship, awarded by Equal Justice America, supports law students working in legal aid programs, emphasizing the importance of pro bono legal work for underserved communities.
