Update 1: My internship with the Public Benefits division of Legal Aid Chicago began about two weeks ago. The orientation on my first day was wonderful, I met so many amazing attorneys and interns and I learned so much about all the important work that Legal Aid Chicago does for our clients, and the enormous impact that they've had on Chicago's communities.

Since my first day, I've been trained on application & appeals processes for public benefits, and I've gone to so many fun lunch talks with experienced professionals from all of Legal Aid Chicago's practice groups. The major projects that I'll be working on for the rest of the summer are all lined up, and I can't wait to do some great work! I'm so excited to represent the University of Michigan Law School this summer as I pursue my career in public Interest!

Update 2: My internship has continued to be a rewarding and educational experience. I've had the privilege of working at the Garfield Community Service Center, performing intake interviews to assist individuals in submitting requests for medical, food and cash benefits. It is incredible to see the impact of my work in helping my neighbors and community get stability and support in their lives.

My work so far at Legal Aid Chicago is very comparable to the kind of direct-client legal service work that I have practiced as a Student Attorney in The University of Michigan Law School's student clinics.
