Dear Mr. Ruben:

I spent this summer in the Clean Slate Practice group of the East Bay Community Law Center (EBCLC). I had a wonderful experience, so much so that I will continue to work there part-time this semester as part of my clinical education at University of California, Berkeley, School of Law.

In ten short weeks, I was able to learn a great deal about criminal records remedies in California, as well as more broadly collateral consequences of being involved in the criminal justice system. I was quickly trained and then was able to put into practice client interviewing and interaction skills, as well as broader legal skills including research and writing.

My absolute favorite part of the summer was the weekly drop-in clinic. I would go to Hayward every Monday, to staff a drop-in legal clinic for individuals with criminal records. Within a few weeks, I was able to meet with clients on my own, assess the best legal advice to give them, check-in with a supervisor, and then deliver that advice to my client. More often than not, I was able to take a client on, or help them to fill out their *pro per* paperwork to file for California Penal Code § 1203.4 dismissals on their own. I was also able to help to empower individuals in applying for jobs and knowing their rights when it comes to background checks. Many clients had more complicated problems, and I would enjoy coming back to the office, researching an appropriate answer and working with the client to help them to secure housing or pursue employment.

One of my favorite clients is a young man, who early on in their adulthood, was convicted of two misdemeanors soon after he legally became an adult. He is in his late twenties now, and is looking to become a public school teacher. I believe he will be a fantastic teacher as well as a mentor for students in his community. I was able to help him to get his convictions dismissed. However, he is having difficulty getting the proper certification to begin the teaching credential process due to his criminal history. I look forward to continuing to work with him to navigate the certification process to guarantee that he is indeed able to fulfill his dream of becoming a teacher.

My summer at EBCLC meant the world to me. It solidified my desire to continue to work in

direct legal services throughout law school and to start my legal career. I enjoyed the fast-paced and collegial nature of working in a legal services organization, and I believe that I was truly able to make a difference in the lives of my clients.

I am thrilled to be continuing to work with the Clean Slate Practice this semester, as I will soon be certified by the State Bar of California to appear in court. I will be able to represent some of the clients that I took on this summer, and continue with them through the court hearing process.

I had the pleasure of supervising Shana Heller this past summer at the East Bay Community Law Center (EBCLC). Shana is an exceptional legal advocate with a strong commitment to public interest work. Thanks to your generous funding, Shana developed her considerable skills this summer working in our Clean Slate Practice.

I am the director of the Clean Slate Practice at the East Bay Community Law Center (EBCLC), a legal clinic of Berkeley Law School (Boalt Hall). The Clean Slate Practice provides legal services to low-income people with criminal records who are attempting to reenter society as full and productive members. Additionally, the Clean Slate Practice advances policy initiatives that aim to expand the civic participation and advance the rights of people who have had contact with the criminal justice system.

This past summer, Shana's work included client interviewing and counseling, legal research and writing, and document drafting.
