Dear Mr. Ruben:

Thank you and Equal Justice America for giving me the opportunity to work at the Child Advocacy Law Clinic at the University of Michigan Law School this summer. I was able to work with some wonderful individuals and provide service to children, parents and families in need of legal assistance.

The Child Advocacy Clinic (CALC) is the oldest child welfare law clinic in the country. It provides families with direct aid by representing them in trial court proceedings. The cases generally deal with child abuse and neglect, child custody, and termination of parental rights issues. Additionally, the supervising attorneys and students at CALC look beyond solely legal needs, and strive to aid in other important aspects of our client's lives.

As a student attorney, I had the opportunity to work closely with supervising attorneys and fellow student attorneys on a dozen cases. I worked with an incarcerated parent who was fighting to regain custody of his son pending his eventual release from prison. I also worked to track down another client who ran away several times from her foster home after becoming jaded by the foster care system. Most of our clients face not only legal problems but also struggle with medical and socioeconomic hardship. As a result, I learned that although we are first and foremost lawyers, in certain situations we take on the roles of social workers and mentors.

Among the numerous clients I had a pleasure of working with, I developed a close relationship with one client in particular. My client was a seventeen-years-old young woman who struggled with termination of parental rights issues and had been placed in a foster home. In addition to her legal situation, she also dealt with various health and financial problems and was not receiving the services she needed from her caseworker from the Department of Human Services (DHS). After months of close coordination with the court and the DHS supervisor, I was finally able to help my client make some much needed progress in her life. She is now graduating high school a semester early and has started her college application process. She has been assigned a new caseworker and recently started receiving monthly financial assistance from the government. And most importantly, she told me that she finally feels like she is receiving the help promised to her a long time ago. I feel tremendously fortunate to have taken part in shaping this young woman's life for the better.

The Child Advocacy Clinic is a phenomenal legal clinic with amazing attorneys and support staff. I chose to work there this summer because of the clinic's reputation for providing its students with real world client-interaction and litigation experiences. And I'm happy to say that I

learned all of the above and more. Thank you Equal Justice America for your support in this experience.


