Entry 1: 6/19/2019

A few weeks ago, I began my summer internship working in Los Angeles at Human Rights First in Refugee Representation. I have conducted intakes with potential clients seeking asylum and drafted detailed reports with extensive country conditions documentation and legal analysis. Last week, I interviewed a Venezuelan man who has lived in both Venezuela and Mexico. Unfortunately, he has suffered significant verbal and physical abuse as well as employment discrimination because he is a member of the LGBT community and HIV positive. I worked with my supervising attorney to evaluate any eligibility issues regarding his case, determine what the next steps should be, and how to best help. I am incredibly grateful for the opportunity to help provide quality legal representation to asylum seekers while working with attorneys dedicated to upholding human rights. I am proud to be an Equal Justice America Fellow.

Entry 2: 7/09/2019

I can't believe I only have about one month left of my internship with Human Rights First. Right now, I am collaborating with outside experts to provide a written affidavit regarding country conditions in Honduras for an asylum case. I am also preparing the declarations of a man and his family from Honduras who have been threatened and extorted by criminal gang members. Later this week, I will get the opportunity to interview a client and his daughter in Spanish. I am looking forward to further developing my client communication skills. I am incredibly grateful for the opportunity to help provide quality legal representation to asylum seekers while working with attorneys dedicated to upholding human rights.

Entry 3: 7/25/2019

The last couple weeks of my internship with Human Rights First have gone by so quickly. Over the past week, I had an incredible experience interviewing a man from Nigeria and I met his wife and children. I learned about their hardships and journey to the US. I have been writing an intake involving their escape from female genital mutilation and torture. Later this week, I will get the opportunity to meet with a client from Honduras to finalize her application for employment authorization. I am incredibly grateful for the opportunity to help provide quality legal representation to asylum seekers while working with attorneys dedicated to upholding human rights. Entry 4: 8/2/2019

I can't believe this is my last EJA update. During the last week of my internship, I interviewed a transgender woman from El Salvador. Due to a lack of acceptance from her community and family, she became homeless and was forced into prostitution and drug trafficking. I worked with my supervising attorney to evaluate any asylum eligibility issues regarding her case and conducted some legal analysis on whether her drug trafficking offense constitutes a serious nonpolitical crime. Working with asylum seekers this past summer has been an incredible experience-their unwavering strength and determination to build a better life is inspiring. In addition, the staff at Human Rights First provided a collaborative and supportive environment where I was able to grow and become a better attorney and person.
