Week of July 27th

The fact that August 1st is tomorrow is hard to wrap my mind around. This summer has been different, unpredictable, and even a little stressful. So much of life is up in the air for me, for everyone, and the reality of this state of limbo is not lost on me – especially when I am on the phone with clients who were elated following the #SCOTUS DACA decision, only to find out this week that it may mean nothing for their situation. This summer my eyes have been more widely opened to many injustices in this world, and I am grateful to have had the opportunity to work alongside and under some very passionate individuals at Catholic Charities of the Archdiocese of Galveston-Houston who wake up every day to help those in hard places.
