### Week of June 15th

As I wrapped up my first year of law school (yay!) I have also recently been selected as one of this year's Equal Justice America summer fellows! I am very excited for this opportunity as I am currently a law clerk for Texas RioGrande Legal Aid, which provides free legal aid services for people who cannot afford an attorney in 68 southwestern Texas counties. Through EJA and TRLA I have been given mentorship and experience I would not have been able to receive through law school alone. In the past couple of weeks, working remotely, I have been on the education/special education team in San Antonio! Along with the education team I have been able to aid clients through research, translations, and memos. My ability to speak Spanish and translate legal documents for Spanish-speaking clients has allowed me to aid parents of children who would otherwise struggle to receive the same opportunity to be able to read important information. I have also been working with young clients with individual differences who are not getting the educational services they have a right to, even amidst the pandemic. These are a few of the several cases that I have had the opportunity to help advocate for. TRLA has helped me see that it takes more than analyzing laws to help a client, one must also learn how to become an effective voice for the voiceless.

Estoy muy emocionado por esta oportunidad, ya que soy asistente legal de Texas RioGrande Legal Aid, que proporciona servicios de asistencia legal gratuitos para personas que no pueden pagar por un abogado en 68 condados del suroeste de Texas. A través de EJA y TRLA me han brindado apoyo y experiencia que no habría podido recibir solo a través de la facultad de derecho. ¡En las últimas semanas, trabajando de forma remota, he estado en el equipo de educación / educación especial de San Antonio! Junto con el equipo educativo, he podido ayudar a los clientes a través de investigaciones, traducciones y notas. Mi habilidad para hablar español y traducir documentos legales para clientes que hablan español me ha permitido ayudar a los padres de niños que de otro modo tendrían dificultades para recibir la misma oportunidad de poder leer la información importante. También he estado trabajando con clientes jóvenes con diferencias individuales que no reciben los servicios educativos a los que tienen derecho, inclusive en medio de la pandemia. Estos son



algunos de los varios casos que he tenido la oportunidad de ayudar a defender. TRLA me ha ayudado a ver que se necesita más que analizar leyes para ayudar a un cliente, también se debe aprender cómo convertirse en una voz efectiva para los que no tienen voz.
