




## Summer 2021 EJA Fellow:

So far, I've been able to assist clients in claims regarding housing law, family law, bankruptcy law, public benefits, and other fields of poverty law.

In Virginia, a Warrant in Detinue is a procedure where one party may recover possession of unlawfully withheld personal property by another party. I am extremely proud of the work I have been able to do through BRLS this summer and I look forward to learning more about providing civil legal aid.

**Entry 4:** This is my final EJA Fellow Update of my summer with Blue Ridge Legal Services, Inc. (BRLS). This week, I continued working on matters in creditors' rights, property, and family law, while I also began working on housing law matters under the CARES Act. Specifically, I've been researching whether certain eviction provisions still apply with the end of the federal eviction moratorium. The CDC extension of the federal eviction moratorium ended on July 31, 2021. The moratorium protected tenants from eviction for nonpayment of rent. With the end federal eviction moratorium, it is crucial that aid organizations are prepared to assist clients that are especially at risk due to the ongoing pandemic.
