After finishing up an unconventional first year of law school at University of Virginia School of Law, I'm excited to share that I've been selected to serve as an Equal Justice America fellow at Just Neighbors, a non-profit providing vital immigration services to low-income immigrants, asylees, and refugees.

Kindness and professionalism are not mutually exclusive, and when dealing with an immigration system that is oftentimes adversarial, I'm learning that we must do our best as advocates to mitigate re-traumatization whenever possible.

Hi everyone – I'm back with a third EJA Fellow Update. Today is a reminder that although our current administration is working to undo the restrictive immigration measures taken by the previous administration, there will still be rulings that will negatively impact our clients' cases. With a federal judge in Texas now declaring the DACA program illegal and halting new enrollments, hundreds of thousands of individuals are once again catapulted back into immigration limbo – my client being one of them. Delivering this news will be hard, but I am hopeful this is just a temporary setback. In the meantime, we'll be pushing forward and looking for new avenues of relief.

It's time for my fourth and final EJA Fellow Update! I'm happy to announce that I'll be staying on with Just Neighbors for the fall semester! When I first started my internship, I didn't realize how invested I would become in the cases I've been working on. As my official "end" date approaches, it's great knowing I'll be able to continue working on these cases in the fall and even see some of them to completion! I'm particularly excited about having even more time to explore the different areas of humanitarian-based immigration and to refine the skills I've developed over the summer.
